CAUSE OF INJURY: On October 21, 2004, at approximately 4:00 p.m., Plaintiff was traveling near the intersection of Okeechobee Boulevard and Military Trail when his vehicle was allegedly rear-ended by Defendant's vehicle, causing Plaintiff's vehicle to collide with the vehicle in front of him.

NATURE OF INJURY: Plaintiff had his right hand on the steering wheel at the time of the impact. Orthopedic surgeon, Dr. Jeffrey Kugler, performed arthroscopic surgery on Plaintiff's right shoulder and debribed what Dr. Kugler visualized as a full-thickness tear of the rotator cuff. Plaintiff also experienced neck pain from the impact. MRI of Plaintiff's cervical spine revealed disc herniations at C4-C5 and C5-C6 with spinal cord compression and impingement of the C6 nerve root. Plaintiff underwent a series of cervical epidural steroid injections which provided only minimal relief. Surgery was recommended. Defendant argued that Plaintiff's injuries were not caused by this accident. Plaintiff presented evidence of past lost wages of \$ 60,000 with a continuing wage loss of \$ 20,000 per year. Plaintiff's past medical expenses were over \$ 35,000. Plaintiff asked the jury for over \$ 250,000.
