CAUSE OF INJURY: On September 4, 1999, while performing the duties and functions of a conductor/trainman in Defendant's Baldwin Yard, Plaintiff was required to be transported in a van. The transportation of train crews is an essential operational procedure of railroading and had been delegated by contract to a transportation company hired by Defendant. While being transported in the van operated by Defendant's agent, the driver of the van, who was allegedly exceeding the speed limit, struck a pothole, causing Plaintiff to strike his head on the roof of the van. Plaintiff claimed that Defendant negligently failed to provide him with a safe place to work as required under the Federal Employer's Liability Act.

NATURE OF INJURY: Aggravation of pre-existing condition; spinal stenosis at C6-C7 requiring fusion. Dr. Cauthen was Plaintiff's treating physician.
